Reason(s) for rejection:

<u>Completeness of Bid</u>: The List of Goods and Delivery Schedule is not signed and is not fully compliant with the required delivery days after contract signing as only the dates have been copied, not the number of days. The bid does not contain a statement of technical compliance, no technical documentation, prospectus or leaflet has been found in the bid.

<u>Substantial Responsiveness</u>: The original bid (not the copies) contains a double color picture of a motorcycle of the brand BAJAJ with a type indication PLATINA. The type of motorcycle proposed and visualized by this picture is completely not in conformity with the model described in the technical specifications in the ICB document.

Reason(s) for rejection:

Completeness of Bid: The Conformity Declaration in the bid is not backed by any technical documentation, leaflet or brochure. The Conformity Declaration itself is a copy of the technical specifications as required in the ICB document. None of the documents or declarations in the bid have been delivered on letter paper from one or both of the companies in the JV, or show the company's respective letterheads and logo's to the confirm the authenticity of the Manufacturer's Authorization and the Power of Attorney.

<u>Substantial Responsiveness</u>: The bid includes a 'guarantee letter for the service center in Yangon and Naypyitaw' in which it is stated that both partners in the JVC only guarantee to set up an establishment agreement prior to the signature of the contract. This commitment is not in line with the requested firm statement required in the ICB document as a result of which, and as foreseen in ITB 36.3 the Evaluation expressed a negative determination with regard to the qualification of the Bidders to perform the contract satisfactorily.
