Department of Rural Development TERMS OF REFERENCE SENIOR COMMUNITY FACILITATOR (LOCAL STAFF)

(3 Facilitators in each of Bokepyin township, Tanintharyi Region and Ywangan township, Shan State) Background

The Department of Rural Development (DRD) under Ministry of Agriculture, Livestock and Irrigation (MoALI) is implementing the Enhancing Rural Livelihoods and Incomes Project (ERLIP) funded by the ADB and the National Community Driven Development Project (NCDDP) financed by the World Bank Group across the country including some townships in Tanintharyi Region and Shan State. ERLIP was introduced in Bokepyin Township (Tanintharyi) since 2015 and in Ywangan Township (Shan) since 2016. One township in Tanintharyi Region and 3 townships in Shan State are ongoing implementation under the NCDDP. The objectives and status of these two projects are as follows:

ERLIP:

The ERLIP is a community- based development project, supported by a grant of USD12 million through the Japan Fund for Poverty Reduction (JFPR) administred by the ADB, implemented by the DRD and aims to stimulate economic activities in sixty three (63) priority village tracts in three (3) selected townships in rural areas of Myanmar, by focusing on livelihoods and income improvement interventions linked to productive rural and social infrastructure. The project overall objective is to improve productivity and enhance livelihoods in selected rural areas. The project consists of three components (1) Mobilizing and organizing communities (2) Improving village and village tract level infrastructure and rural livelihoods and (3) Institutionalizing project management services. Since the project start in 2013, over 400 rural infrastructures are implemented. However project remains to complete some activities for monitoring of the infrastructures and rural livelihoods under the component 2 of the project.

The Department of Rural Development under the Ministry of Agriculture, Livestock and Irrigation of the Government of the Republic of the Union of Myanmaris implementing a World Bank co-funded project in Myanmar called "National Community Driven Development Project (NCDDP)" since September 2013. Financing for the NCDDP is provided by the Government of Myanmar, the World Bank and the Government of Italy with around \$500 million in financing committed to the program, which is scheduled to run until November 2021.

The NCDDP seeks to enable poor rural communities to benefit from improved access to and use of basic infrastructure and services through a people-centered approach, and to enhance the Government's capacity to respond promptly and effectively to an eligible crisis or emergency.

By the fifth project cycle, the program had financed just under 31,143 sub-projects identified and implemented by communities, improving schools, health centers, foot paths, jetties and other critical community infrastructure serving about seven million people. NCDDP Cycle 5 is currently being implemented in total 63 townships, with the support from the 15 Regional/State Offices, and will expand to additional 13 townships in Year 6 (2020/2021).

Objective and Purpose of the Assignment

The purpose of this assignment is to assist the DRD in Bokepyin and Ywangan townships and to provide technical assistance to the communities in these two townships in implementation, monitoring and phasing out processes of the sub projects under both NCDDP and ERLIP. The senior facilitators will serve as

livelihood facilitators for the ERLIP in Bokepyin and Ywangan townships as the project components include and being implemented for community livelihood improvements as per the ERLIP Operations Manual (OM) and relevant technical information.

Detailed Duties

The senior facilitator will adhere to the following duties and responsibilities including but not limited to the following:

- Assist Bokepyin in Tanintharyi or Ywangan in Shan state communities in the all aspects of project implementation as outlined in the OM.
- Provide technical advice regarding relevant livelihood activities that would include crop production, livestock raising, management of group finances, etc.
- Monitor Livelihoods activities as per the Operational Manual.
- Report as necessary and/or monthly to the Tanintharyi Region or Shan state NCDDP secretariat and Union NCDDP secretariat.
- Assist the livelihood groups and communities in the process of livelihood sub-project closing that would help establish linkages with relevant outside technical support groups for continued operation and maintenance of the sub-projects (for necessary inputs or technical assistance, etc.), for record retention, etc.
- Collect data on livelihood sub-project implementation and results to be used for the township completion report.

Administration

The Senior Facilitator will be based at the respective project township (DRD Office) with frequently visit to the State/Regional Office when requested. The selected facilitator will be contracted for 12 months full time duration.

Minimum Qualification Requirements

The Senior Facilitators should have the following relevant practical experience:

- Any university bachelor degree in relevant discipline (for example, agronomy, livestock sciences, etc).
- At least 3 years (36 months) working experience as community extension agent or facilitator in similar projects; direct experience with the NCDDP or the ERLIP an advantage.
- Familiar or fluency in the local language in and detailed familiarity with the (assigned) project areas will be advantaged.
- Good computer skills on MS Word, Excel and Power Point.
- Good skills in the reporting writing and presentation.

Remuneration and reimbursable allowances

The monthly remuneration rate will be decided by DRD based on the qualifications of the selected CF. The facilitator will be provided MMK-10,000.00 per day as periderm allowance during the visits to the State/Regional Office, MMK-20,000.00 as for communication fee, MMK- 50,000.00 for housing allowance at the duty station and other allowances well be in actual cost under prior authorization of DRD.
